 1. Next steps to be awaited, how this could be then practically implemented in an open way
2. Guarantees
 - a. G8 – Customs guarantee progress still pending in the Finnish case
 - b. G14 – Consolidation of the changes needed, based on the use case studies, has been discussed by Saira and Harri in a different session. For example some changes cases could be including all the semantic mode fields instead of the change delta only. Some mechanism for the change can be designed into the semantic model. Harri will match the possible change needs compared to the work in the Documentary Credit session and modification. Review to be available on the 7th of February meeting, 2024 for aiming to public review.
3. Documentary Credits
 - a. DC2.1 & DC2.2 – Based on Vlada's and Saira's good base work with use case testing, Saira and Harri made some further adjustments with questions needing answers. Harri also composed a draft json schema and sample for review. We will arrange a smaller task force meeting on the 9th of Jan, 2024 to have agreement on the composed open pointers to get a sample model and case available on the 7th of Feb, 2024 meeting. Also considering how to publish the schema for more open reviews.
